A motion was duly made by Treasurer Suberi, seconded by President Duncan, and unanimously carried to approve the transfer of funds for non-recurring expenses in the amount of \$44,966 to Handa Construction as a progress payment for the community painting project (invoice #4124), Dils Roofing in the amount of \$58,840 as the final payments for phase #3 roof replacement (invoices #481538, #481450), and Perry Plumbing in the amount of \$16,330 for plumbing repairs (Invoices #81440 & #81370) to be in compliance with Civil Code Section §5502.
